

- iv. Ordinary Diploma in Accounting and Finance (TCAF)
- v. Ordinary Diploma in Human Resource and Management (TCHRM)
- vi. Ordinary Diploma in Social Work (TCSW)
- vii. Ordinary Diploma in Local Government Administration and Management (TCLGAM)

The non-degree programmes are designed to equip candidates with knowledge and skills to enable them to become effective change agents with the capacity to collaborate with other extension staff to spearhead development at grass root levels.

In more specific terms the holders of these qualifications are expected to apply skills and knowledge in a broad range of community development work activities, most of which are non-routine.

Course Objectives

- i. To analyse the community development process, apply it in a real-world context, and identify specific conditions that either facilitate or impede community development within a target community.

- iii. To analyse prevalent community issues and concerns, and propose practical, evidence-based solutions to address them.

2.2.2.2. Bachelor of Project Planning and Management (BPPM)

- ii. To establish a participatory monitoring and evaluation system that enhances project effectiveness and ensures long-term sustainability.
- iii. To build the capacity of the community to improve overall community wellbeing through education, healthcare, and social support programs.
- iv. To empower the community with the knowledge and skills required to explore diverse economic options for sustainable development.

2.2.2.3. Bachelor of Gender and Community Development (BGCD)

Course Objectives

- i. To establish gender equality initiatives that actively address disparities across institutions and sectors within the community.
- ii. To develop the community's capacity for effectively managing assets and exploring a diversified range of economic options.
- iii. To expand economic development opportunities by enhancing the skills and capabilities of the community's workforce.
- iv. To foster social cohesion and build community social capital by implementing programs and initiatives that strengthen community bonds.

- vi. To impart knowledge and skills to learners that enable them to capacitate communities to assess and analyse problems and opportunities and develop effective solutions.

2.2.3.2. Master's Degree in Project Planning, Monitoring and Evaluation (MPP-E&M)

Course Objectives

- i. To effectively apply acquired skills to plan and design a Monitoring and Evaluation (M&E) system tailored to the needs of a given program or project.
- ii. To proficiently utilize qualitative and quantitative impact evaluation techniques to assess the performance and outcomes of programs and projects.
- iii. To apply knowledge and skills in resource mobilization, financing, investment analysis, budgeting, procurement, and reporting to ensure efficient, effective, and accountable utilization of project financial resources.
- iv. To competently apply ICT and Management Information System (MIS) skills in the collection, processing, analysis, storage, and dissemination of information, ensuring the integrated use of data for project planning and management.
- v. To adeptly apply qualitative and quantitative methods and techniques of research design, data collection, processing, analysis, and interpretation in the context of project monitoring and evaluation.

2.2.3.3. Master's Degree in Gender and Human Rights (MGHR)

Course Objectives

- i. To train students in applying legal frameworks in gender and development practices
- ii. To train students in applying gender perspectives and analysis skills in gender and development practices
- iii. To equip students with community development skills in gender and development practices
- iv. To provide students with social welfare and social psychology skills in gender and development practices

 Bachelor's Degree lower second for classified award or an average of B grade or credit for unclassified awards on relevant or related fields from a recognized institution of higher learning;

OR

ii. Bachelors' Degree of pass grade with a post graduate diploma on relevant or related field;

OR

iii. Advanced Diploma from a recognized Institute or equivalent qualifications.

An Ordinary Diploma (NTA Level 6) in Community Development, Development Planning, Education, Statistics, Economics, Development Administration and Management, Business Administration, Local Government Administration and Management, Cooperative Management and Accounting, Marketing Management, Local Government Accounting and Finance, Procurement and Supply, Public Sector Financial Management, Development Economics, Public Policy and Planning, Agriculture Economics, Human Resource Management, Business Planning, Land Use Planning, Cartography, Project Training, Law; and Gender and Development with an average of 'B' or at least a GPA of 3.0 or above.

3.3.2. Computation of GPA
